

New Hope Christian Academy Parent Contract HOME OF THE "LIONS"

This Agreement, dated _____ entered by and between New Hope Christian Academy, hereinafter called Academy, and _____, hereinafter called Parents. In consideration of the mutual covenant and agreement herein contained the parties hereto agree as follows:

1. The Academy agrees to maintain and operate New Hope Christian Academy on the premises generally known as 1520 W McHaney Rd, Harrisburg, Illinois for grade levels K3 through Twelfth for the 2018-2019 school term, and to provide educational instruction for children of parents listed in item 2.
2. The Parents agree to the enrollment of the following children in the Academy and indicate their home church they will be attending (for multiple students see last page):

3. The Parents understand that the Academy is an interdenominational school and will have activities which focus on the worship of God; the Parents understand and agree to such policies of the Academy and, in particular, the Parents understand and agree that Scripture will be read, Scripture will be studied, and prayers said daily in each grade level. The Parents also agree to have the student(s) attend the church of their choice on a regular basis.

4. The Parents understand and agree that discipline of the student(s) is their responsibility as well as that of the Academy. The Parents further understand and agree that discipline will be enforced in the Academy in a reasonable manner (refer to the school wide discipline policy in the Handbook). The Parents further understand and agrees that the child may be searched by the members of the administration, if it is suspected that the student(s) has drugs or other undesirable articles at the Academy. Also, the Parents understand and agrees that students involved in extracurricular activities could be tested for drugs and/or alcohol according to the school policy. I also give permission for my children to take part in all school activities including sports and school-sponsored trips away from the school premises, and absolve the school from liability to me or my children because of any injury to my children at school or during any school activity.

5. The Parents understand and agree that the student(s) may be discharged from the Academy in the event that the administration and the school board agree that the dismissal of the student(s) is necessary in the best interest of the Academy, the student(s), or the other members of the class, and that this will not relieve the Parents from obligation to pay the Academy the total stated in item 11, in the manner provided therein, Tuition will not be refunded.

6. In the event Parents advise the Academy in writing that they desire to cancel this contract before June 1st, 10% of the Academy tuition in item #11 will be assessed. The penalty fee assessed on or after June 1st till the first day of school is 30% of the total Academy tuition.

7. Job Transfer: In the event a family moves away from the Southern Illinois area necessitating the student(s) removal from the Academy during the school year, provided notice is given fifteen (15) days prior to the student(s) removal from the Academy, the remainder of that month's tuition will be retained by the Academy, but the remaining balance on this contract will not be enforced.

8. Early Withdrawal: In the event the student(s) is withdrawn from the Academy the first day of school or after and before the end of the contracted period, a penalty fee of 30% of the total Academy tuition will be assessed in addition to prior payments due through the students last month of attendance.

9. It is understood and agreed that in the event that the payments for the cost of tuition are not made on or before the date indicated in accordance to Academy policy or the method of payment selected or within (10) days thereafter, the entire balance due on this Parents' Contract will become due and payable and the student(s) will not be accepted in the class until such time as the payment is made.

10. It is further understood and agreed by the Parents of the student(s) that the records of the student(s) will not be released if payments required for tuition in this contract, lunches, or book replacement costs have not been made.

11. Statement of Charges:

If selecting to pay in full or by the semester, a service charge of \$30 may be added each month to any unpaid balance. In the event Parent fails to make payments or perform the covenants herein received of Parent, Parent agrees to pay in addition received hereby all cost of collection including reasonable attorney fees and court cost incurred by Academy as a result thereof.
